Briefly summarise what has led to this assessment for the child and family										

Mom Hazel has previousley had a child removed due to alcohol misuse and depression. She was also a victim of Domestic Abuse with a previous partner. Her two current children who she has with current on and off partner Saif, were subject to a CP and CIN plan, which was closed in March 2020. Hazel has worked well with professionals, remaining open honest and engaged, however Hazel recently asked Saif to leave the property, as she wasn't happy with lack of support and his behaviour at times both with herself and the children. This was seen as a risk to Hazel's own health and well being, given her past experiences and Saif's history.

Saif is now staying back at the property, however their relationship status is unknown. Hazel is now taking anti-depressents for her own mental health. Hazel continues to engage well with all professionals including myself Theresa-Health Vistor, Anna-FSW and Emma Womens Aid Support Worker.

Dad Saif has a Probation and police offender manager.

Hazel and Saif do not work, but are claiming the appropriate benefits.

Crime and Anti-Social Behaviour:
Saif has been keeping out of trouble and focusing on being a better dad and partner to Hazel. This means he is spending more time with his children. He has said, "I want to turn my life around and stop doing the stupid things I was doing. I don't want to go back to jail or put my family through that. I want to be a

Saif has a history of drug and theft related offences. Saif said, "I understand the choices I have made in the past have hurt my family and having children has made me want to change my ways, so that they don't grow up following my footsteps. I don't want to lose my children"

#### Domestic Abuse:

Saif has previously been arrested for domestic abuse in a previous relationship. Hazel said, "Saif has never physically hurt her and he loves his children. If we have had arguments, the children are normally asleep. I have been in a really bad abusive relationship before Saif and I have had my eldest child taken off me. I would never put Seema and Asma through that and Saif knows this and understands."

Saif to continue to engage with his probation officer and Police Offender Manager.

Domestic Abuse:

Emma: Hazel and Saif need to understand the impact their actions and behaviour at times can have on Seema and Asma. Freedom project to be re-alliterated to Hazel and further work to be done with Saif.

Hazel to inform Professionals if she feels down or isn't happy with her relationship with Saif.

Saif to maybe have Asma so that Hazel can spend time with Seema who needs more interaction and time from her parents. This will also benefit either way.

Theresa: Seema and Asma are both in good routines and are always well presented.

Worklife, Financial and Housing Saif and Hazel said "we both believe we meet our children's basic needs and do not struggle financially."

Crime and Anti-Social Behaviour Saif explained, "I used to be involved in the wrong crowd and was getting into a lot of trouble with the police, for theft and selling drugs. I used to smoke cannabis, but I stopped that before I met Hazel. I do still drink but only occasionally with a few friends. I don't drink in the house anymore and never in front of the children. I know I have acted stupid in the past when I have got really drunk and I know Hazel doesn't like it. I have been working with my probation officer and my offender manager. I have kept all my appointments. I have been applying for work and keeping my nose clean."

#### **Domestic Abuse**

Hazel acknowledges she wants to work towards a healthier relationship with Saif for Seema and Asma to be free from emotional abuse. Hazel said, "I have been working with Emma Grate from bswaid and she has been supporting me. She will keep in touch with me over the Theresa: Saif believes he is always helpful to Hazel and that he doesn't do anything to upset her. Meaning he doesn't see how he can upset Hazel at times with his behaviour.

Hazel said, I am worried that Saif may go back to his old ways, even though he keeps telling me that he won't. I want to believe him but sometimes I can't and this can start to cause tension between us.

Hazel said, "Saif can be over protective and will call me every 2 minutes if I go out. He wants to always know where I am and who I'm with. He will always ask me who I'm keeping in contact with. He has all our benefit money, so he knows when I'm Crime and Anti-Social Behaviour Saif said, "keep all my appointments with my Probation Officer and Offender manager. Don't get into any trouble as I am on licence and I don't want to go back to jail."

#### **Domestic Abuse**

Hazel said, "I want Saif to stop calling me all the time when I go out to the shops or to my parents. I want him to stop blaming me for getting upset with him. I want Saif to get some professional support, so he can understand that his behaviour can make me feel upset and low. Continue to work with Emma.

Grandmother and aunty were also spoken to, they both feel Hazel has been doing really well with the children's care and think that her anti depressants have been helping her with her low mood. They feel Saif has also stepped up with his responsibility and is trying to be more supportive and helpful around the house and with the children. If Hazel is tired, he will take care of the girls and cook for Asma and Hazel.

Saif said, "Hazel doesn't have her own bank account due to the covid-19 lock down preventing her from getting an account opened. That's why I have given her a card to one of my bank accounts, which she can access when she wants. Also, because of how she has been feeling, I call her to make sure she is okay."

Grandmother and Aunty were asked if they had any concerns, they said Saif can be controlling and will want to know Hazel's whereabouts all the time, even when she is just going to the shops to get some nappies for the children.

#### View of those working with and supporting the whole family directly in partnership with others

### What is going well

(1) Laura Norder (Police Offender Manager's feedback) - engagements with Saif have been positive, there have been no recent intelligence that he has been involved in any criminality or anti-social behaviour. It appears that he is actively seeking employment and has registered with a traffic management agency, that will be able to assist him with finding work, this work could take him anywhere in the country.

Natalie Doogooder (Probation Officer's feedback) - Saif has expressed his thoughts about his past behaviour and the impact this has had on his family. He is wanting to have a better relationship with his family and understands in order to do this, he must distance himself from his previous associates and look to obtain gainful employment. He has often spoke fondly of his children and understands he needs to be more supportive of Hazel and the children's needs. Saif is adhering to the conditions of his licence. If he breaches his licence conditions, he is aware that he would go back to prison

- (3)Asma has a good relationship with both her parents and Seema has been observed to be bonding well with Hazel and Saif.
- 4)Seema and Asma are housed; they are safe and appear financially supported by mom and dad. Their basic needs are been met, and it is evident that they are well cared for by Hazel and are loved. Hazel always engages with professionals and appears to be honest with anything asked of her. Hazel's mom and sister help by taking care of the children to give Hazel and Saif some respite.
- (5) There have been no reports of domestic abuse reported by Hazel and both parents seem to be getting on with each other better. Saif has started to help more in the house and has been more supportive of Hazel.

Emma Grate (bswaid worker's feedback) – Hazel has been engaging and listening to advice on how to keep safe. Face to face sessions have not been possible due to covid, however I have been keeping in regular contact with Hazel over the telephone.

(6) Asma is a clever active little girl for her age. Seema is also developing well for her age, she has a low weight but was born at a low birth weight too, regular weights are been carried out to ensure she thrives as she should. Both children are also up to date with their immunisation.



#### What are we worried about

- (1) Hazel is worried that Saif may return to his old life. Saif used to be involved in selling drugs and theft related offences. Hazel's concerns are triggered when Saif talks about his old friends. If Saif gets into any trouble whilst on licence he would be going back to prison. This could potentially leave Hazel to take care of the children on her own and impact on their relationship. Saif has expressed he doesn't want to lose his children and that he wants to turn his life around. Saif has been working with professionals to make appropriate changes.
- (3) Anna Littical (Family support worker's feedback) Concerns of isolation for Hazel and the children who may be having limited interactions outside the family. This may cause Hazel to become more reliant on Saif, which could affect her independence and metal wellbeing. If Hazel can get out more attending groups once they are open following a Covid-19 lockdown she will be able to socialise more, become more independent and Asma will be able to thrive off the interactions with other children. (6) Hazel has been feeling depressed. She is currently taking prescribed antidepressant medication to control her low moods, which appear to be helping. Hazel has been concerned about her mental health impacting on her children. Saif needs to be more understanding of Hazel's metal wellbeing so that he can support Hazel better when she gets upset. Saif does not feel he upsets Hazel and blames her depression for her low moods. Hazel has agreed to let professional know if she starts to feel low again. If Hazel starts to feel upset in her relationship, this could cause them both to argue, impacting on Hazel's ability to attend to the care of her children or even affect Saif remaining in the family home. At the moment Saif is supporting Hazel in the care of both children. If Saif was to leave, this could also impact on Hazel's wellbeing, as the responsibility of taking care of two very young children will be placed on Hazel. (5)(6) Hazel and Saif need to work on their relationship. The status of their relationship remains unknown, as Hazel and Saif are on and off a lot of the time. Hazel and her family feel that Saif can be quite controlling. It appears that Saif could be using coercive behaviour, to control aspects of Hazel's life. In particular, her finances and who she contacts and socialises with. He will want to know her whereabouts all the time and has her benefit money going into his own bank account. Hazel's mental Health and selfesteem appears to be compromised through Saif's behaviour. If Hazel continues to be unhappy in her relationship and home environment this could impact upon Seema and Asma's emotional wellbeing too. Hazel and Saif have both attended many courses and engaged well with professionals but have not always been able to implement the lessons learnt into their family environment.

Anna and Theresa - Maintain contact to update Hazel on what is available for her to attend as the covid-19 lockdown begins to lift, the update on Hazel and Saif's relationship status and Hazel's mental health.

Theresa – Continue to visit every other week to monitor children's health and development.

Theresa – Support Hazel with her mental health through listening visits.



Theresa – Provide Hazel and Saif with support and advice about healthy relationships.

Emma - To continue to work with Hazel for her well-being and healthy relationships including her relationship status with Saif.

The whole team will continue to liaise as necessary.
