Baby girl born at 30+6weeks, admitted to Birmingham Women's Neonatal Unit for mild respiratory distress. Amanda, mother has a history of Physical Abuse and witnessing Domestic Violence by her stepfather, she is no longer in contact with him. Amanda has recently become a single parent and is quite isolated with some financial difficulties; she has a poor relationship with her father but does have a good relationship with her mother.

- Amanda is doing well and continues to put Rita first, she has also confirmed that she currently has no health concerns for herself

(4) Home Life and Relationships-


- -Amanda is continuing to include Rita's father as much as she can. He has been able to offer Amanda both emotional and financial support when she has needed. He is keen to have a relationship with Rita and will do whatever is necessary of him to support Amanda and Rita. Although Amanda is no longer in a relationship with Rita's father and she has not shared any details about him, the support from him has been positive for Amanda and she has managed to cope well with Rita's extra needs.
- -Amanda also has the support of her mother, despite not having a good relationship with her father. Her mother has offered Amanda respite by cooking meals and dropping them off to her, helped source and purchase some of the furniture for her new flat. Amanda has a good relationship with her mother which has also been positive on Amanda's health and wellbeing. Amanda is hopeful that her father will soon come around and start talking to her. Amanda has a lot of support from professionals, Rita's father and her mother. Once Amanda starts the virtual peer support group sessions, she can start talking to other parents, which could offer her further support.

(4) Work Life, Financial and Housing-

-Amanda is currently not working as she wants to concentrate on being a good mother to Rita. She has shown a very mature character and has a good awareness of financial responsibility. She has moved into a studio flat which has been carpeted and furnished.

	The flat is clean, and Amanda has purchased all necessary items for Rita. As professional's we do not have any concerns for Housing or finances. Amanda receives the correct benefits and has some financial support from Rita's father. Amanda has also stated she has no concerns in these areas.
	(1) Crime and Anti-Social Behaviour There have been no concerns reported from Amanda or other professionals working with Amanda and Rita regarding any crime or anti-social behaviour from her neighbours, community or family
	(5) Domestic Violence Due to Amanda's history of domestic abuse from her stepfather, she is aware of the signs and she has said it has made her stronger as a person and that she would never be put in that position again. Amanda's ability to understand danger and positive relationships can be confirmed by all the professional who have been working with Amanda, as she has demonstrated her ability to be strong willed, responsible and very clued on.

	(6) Health and Emotional WellbeingRita has a SWEAT test to determine a Cystic Fibrosis diagnosis this is on 23/10/2020 at Birmingham Children's Hospital. Amanda is aware of Rita's extra health concerns and needs and has been working well with professionals to address these. Amanda has accepted the possibility of Rita being diagnosed with Cystic Fibrosis. All involved professionals believe that she has made the appropriate preparations for this and has a positive approach to ensuring all necessary appointments are attended for Rita.
	(4) Home Life and RelationshipsAmanda may be at risk of isolation. Although Amanda has the support from Rita's father and her mother. There is some tension between her father, therefore her mother can only offer limited support when she can. Rita's father has been supportive of Amanda and Rita; however, he is not going to be living with them, so Amanda won't be able to fully rely on Rita's father being able to assist her with all Rita's care needs. As Amanda is not living close to any of her friends, she has expressed feeling isolated at

	times. She has no siblings or any close by relative. At present Amanda's wellbeing and health has not been impacted, however if she was to start feeling isolated and having only limited contact with her mother and Rita's father coupled with the extra care needs and appointments for Rita, there is a concern that this could start to impact on her mental wellbeing.
